Government of Nepal has allocated a fund towards the cost of procurement of one 4 WD Jeep Type Vehicle to cover eligible payments under the Contract for 4WD Jeep Type Vehicle.

1. **The Budhigandaki Hydroelectric Project Development Committee** invites sealed bids from the eligible bidders for the procurement of one number of 4WD Jeep Type vehicle.
2. Eligible Nepalese Bidders may obtain further information and inspect the bidding documents at the office of **Budhigandaki Hydroelectric Project Development Committee**, Saraswoti Marg 161, Tripureshwor, Kathmandu.
3. Bidding documents may be purchased on or before 30th day from the date of first notice published from the office of **Budhigandaki Hydroelectric Project Development Committee**, Saraswoti Marg 161, Tripureshwor, Kathmandu by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 1000. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 500. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
4. Sealed Bids with necessary supporting documents must be submitted to the office of **Budhigandaki Hydroelectric Project Development Committee**, Tripureshwor, Kathmandu on or before 12:00 p.m of 31st day from the date of first notice published. Documents received after this deadline shall not be accepted.
5. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 31st day from the date of publication at 14:00 at the office of **Budhigandaki Hydroelectric Project Development Committee**. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security of minimum amount of Rs. 1,05,000.00 cash deposit in Account No. 1700203 (Treasury Comptroller Office, Tripureshwor), or in the form of unconditional Bank guarantee from class A bank in favor of **Budhigandaki Hydroelectric Project Development Committee** which shall be valid for minimum 30 (thirty) days beyond the bid validity period.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. The Employer reserves the right to accept or reject, wholly or partially any or all the bids without assigning reason, whatsoever.
8. Others terms and conditions will be in accordance with the Procurement Act, 2063, Procurement Regulation 2064 and the prevailing laws of Government of Nepal.
