**NOTICE FOR EXPRESSION FOR INTREST (EOI)**

**Package 1: The detailed Engineering Survey of Ring Road around Proposed Budhigandaki Hydro Power Project and Demarcation of its Reservoir in Gorkha District (60 Km).**

**Package 2: The detailed Engineering Survey of Ring Road around Proposed Budhigandaki Hydro Power Project and Demarcation of its Reservoir in Dhading District (25 Km).**

**Date of Publication: 24<sup>th</sup> May 2018**

1. Government of Nepal (GoN) has allocated fund from its own resources toward the cost of detailed survey of Ring Road and demarcation of Reservoir in Budhi Gandaki Hydro Power Project (BGHP) and intends to apply a portion of this fund to eligible payments under the Contract for which this Expression of Interest is invited for National consulting service.
2. The assignment will be split into two packages, namely package 1 Survey and demarcation of reservoir in Gorkha district and package 2 survey and demarcation of reservoir in Dhading District .
3. This EOI has been called to invite applications from interested firms or a Joint Venture (JV) of firms each having minimum 7 years of experience in consulting business in detailed survey & design of Roads/Highways. The maximum number of JV partners shall not exceed three. Formation of association is also not allowed. Eligible interested applicants must provide the information as instructed by the EOI document.
4. Only those shortlisted will be invited to submit "Request for proposals (RFP)".
5. Only one application per package from any firm or a joint venture of there shall be permitted. Firms are not allowed to enter into more than one joint venture whether in lead or as secondary partners.
6. The scope of services for each package shall include but not be limited to:

- Detailed engineering survey of a two lane road based on previous studies and prepares a detailed survey design report and demarcation of reservoir.
  - Compile Land ownership information along road alignment in Excel and GIS format (Private land, guthi land, gov.land and forest)
  - Consultant shall complete survey of all the remaining road length around proposed Budigandaki reservoir within contract amount.
7. The services of the consultants shall have to complete the task within 10<sup>th</sup> month from agreements date.
  8. The EOI documents submitted by the applicants shall be evaluated on the basis of the approved evaluation criteria. The shortlisted consultants will be notified in due course of time for the submission of Technical and Financial Proposals based on the issued RFP. The selection and engagement of the successful applicant among the shortlisted consultants/JV shall be in accordance with the Quality and Cost Based Selection (QCBS/ method with 85:15 ratios for quality and cost and in accordance with the Public Procurement Act 2063 and Public Procurement Regulations 2064 of GON and BGHP Ring Road working policy and procedure.
  9. Three to six highest ranked firms or JV will be shortlisted and will be invited to submit the Request for Proposal (RFP).
  10. Expression of Interest must be submitted electronically through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) by 15<sup>th</sup> day from notice publication at 17:00 hours local time
